




## How to Generate BIR 0619-E Form

### Overview:


**BIR Form 0619-E or Monthly Remittance Form for Creditable Income Taxes Withheld (Expanded)** is a remittance form that is used for remittance of expanded withholding taxes, as mentioned within the provisions of Revenue Regulations No. 11-2018. **0619-E** shall be filed every 10th day of the following month at which the withholding was made.

### Procedure:

1. Go to View > Reports > W/Tax > BIR 0619-E Form.



2. Select/enter the Taxable Month and Year. Tick the 'Amended' checkbox if it is an amended return. Click **Preview**.


